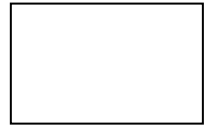

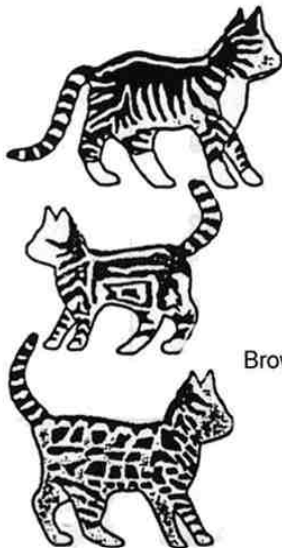
All Black, All Blue (grey)

White with Tortoiseshell Patches, White with Blue-Cream Patches.

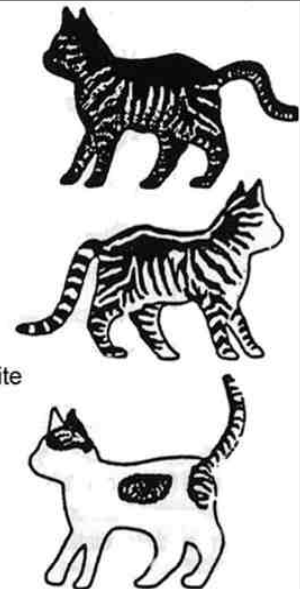


TABBIES GROUP
